The following persons were present: Chairman Hawkins, Vice-Chairman Abbott, Commissioners Bush (Polycom), Kent (Polycom), and Joyner along with County Administrator Jeff Massey, Clerk of Court Lora C. Bell, Finance Director Johnnie Pettis, and Deputy Clerk Risha Brantley.

II. ADOPT THE AGENDA

Commissioner Abbott offered a motion, seconded by Commissioner Joyner, and carried to approve the agenda.

Chairman Hawkins - The purpose of this meeting is to hold the public hearing adopting the millage rate, and budgets for the Washington County Board of County Commissioners, and MSBU for the fiscal year 2020 – 2021.

The Washington County Board of County Commissioners percentage increase above the rolled-back rate is 5.21% of 8.0789. The proposed millage rate for 2020 - 2021 is 8.5000, which will generate \$7,960,537.00.

Chairman Hawkins added an agreement with Leon Ward to provide fill dirt from a pit off of Clayton Road. The agreement will be to provide fill dirt for the west side of the county. The agreement is identical to the agreement with Davy Odom that the county currently has.
