ACTING UPON A REQUEST BY THE DEPARTMENT OF TRANSPORTATION, COMMISSIONER DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER HADDOCK AND UNANIMOUSLY PASSED BY THE BOARD, TO ALLOW TRAFFIC TO BE DETOURED FROM SNUFFY SMITH STORE AT THE INTERSECTION OF SR 277 AND CR 276A TO JOHNSON'S CROSSROADS AND TO AUTHORIZE ANY EXTRA MAINTENANCE ON SAID ROAD WHICH MAY ARISE FROM EXTRA TRAFFIC DUE TO SAID DETOUR. THIS DETOUR OF TRAFFIC WILL ENABLE THE DEPARTMENT OF TRANSPORTATION TO REPAIR THREE BRIDGES ON CR 280.

ON A MOTION OFFERED BY COMMISSIONER DAVIS, SECONDED BY COMMISSIONER CORBIN AND UNANIMOUSLY PASSED BY THE BOARD, ROYACE PITTS, COUNTY ENGINEER, WAS AUTHORIZED TO CORRESPOND WITH THE DEPARTMENT OF TRANSPORTATION TO REQUEST, ON BEHALF OF THE COUNTY, OLD BRIDGE MATERIAL.

PÚRSUANT TO A RECENT INSPECTION BY THE DEPARTMENT OF TRANSPORTATION OF BRIDGES IN WASHINGTON COUNTY, COMMISSIONER CORBIN OFFERED A MOTION, SECONDED BY COMMISSIONER HAYES AND UNANIMOUSLY PASSED BY THE BOARD, TO POST APPROPRIATE WEIGHT RESTRICTIONS ON SEVERAL COUNTY BRIDGES.
