EVERY PROPERTY OWNER IN WASHINGTON COUNTY WAS NOTIFIED OF THE MEETING BY THE REQUIRED "TRIM" NOTICES AND THERE WERE SEVERAL CITIZENS IN ATTENDANCE.

THE CLERK THEN STATED THE PROPOSED MILLAGE OF 9.435.

THE CHAIRMAN THEN ASKED IF ANYONE IN THE AUDIENCE WISHED TO ASK ANY QUESTIONS OR MAKE ANY COMMENTS REGARDING THE PROPOSED MILLAGE RATE OR THE PROPOSED BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1988, AND AFTER HEARING COMMENTS FROM JACK MANNING, REPRESENTING THE WASHINGTON COUNTY VOLUNTEER FIREMEN'S ASSOCIATION AND MOLLY SHUMAKER AND AGNES S. MIRAMONTES, SPEAKING ON BEHALF OF THE WASHINGTON COUNTY LIBRARY AND TRI-COUNTY COMMUNITY COUNCIL, INCORPORATED, THE CHAIRMAN ENTERTAINED ACTION FROM THE BOARD.

ON A MOTION OFFERED BY COMMISSIONER CORBIN, SECONDED BY COMMISSIONER HADDOCK AND UNANIMOUSLY PASSED BY THE BOARD ON A ROLL CALL VOTE, A MILLAGE RATE OF 9.435 MILLS WAS ADOPTED AS THE TENTATIVE MILLAGE RATE FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1988.

ON A MOTION OFFERED BY COMMISSIONER HADDOCK, SECONDED BY COMMISSIONER CORBIN AND PASSED BY THE BOARD ON A ROLL CALL VOTE FINDING COMMISSIONERS CARTER, CORBIN, HADDOCK AND HAYES IN FAVOR AND COMMISSIONER DAVIS OPPOSED, THE PROPOSED BUDGET WAS ADOPTED AS THE TENTATIVE BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1988.
