## SEPTEMBER 12, 1988

HOWARD LOVETT, SPEAKING ON BEHALF OF A LARGE GROUP OF CITIZENS IN ATTENDANCE, REQUESTED THAT THE BOARD CONDUCT A PUBLIC HEARING CONCERNING THE BOARD'S PRESENT CONSIDERATION OF AN AMENDED PROPOSAL FOR A COMPREHENSIVE SOLID WASTE MANAGEMENT PROGRAM SUBMITTED BY FLORIDA GULF ENVIRONMENTAL INCORPORATED AND, ACTING UPON SAID REQUEST, COMMISSIONER CARTER OFFERED A MOTION, SECONDED BY COMMISSIONER CORBIN AND UNANIMOUSLY PASSED BY THE BOARD, TO ADVERTISE FOR A PUBLIC HEARING CONCERNING SAID AMENDED PROPOSAL TO BE SCHEDULED FOR SEPTEMBER 19, 1988, AT 7:00 P. M., TO BE HELD AT THE WASHINGTON COUNTY AGRICULTURE CENTER AUDITORIUM.
