BOARD MINUTES FOR 09/19/88

SEPTEMBER 19, 1988

THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, FLORIDA, DID, AS ADVERTISED IN THE WASHINGTON COUNTY NEWS, A NEWSPAPER OF GENERAL CIRCULATION WITHIN THE COUNTY, HOLD A PUBLIC HEARING ON THE ABOVE DATE AT 7:00 P. M., AT THE WASHINGTON COUNTY AGRICULTURE CENTER IN CHIPLEY, FLORIDA, CONCERNING THE FUTURE OF SOLID WASTE DISPOSAL IN THE COUNTY. ALL COMMISSIONERS, THEIR ATTORNEY AND THE CLERK WERE PRESENT. APPROXIMATELY FOUR HUNDRED (400) PEOPLE WERE IN ATTENDANCE.

PRAYER WAS OFFERED BY REVEREND ROGER D. HAGAN.

THE CHAIRMAN CALLED THE HEARING TO ORDER AND STATED THE PURPOSE THEREOF.

GERALD HOLLEY, ESQUIRE, BOARD ATTORNEY, PRESENTED A SUMMARY OF THE PROPOSALS OFFERED AND THE NEGOTIATIONS WITH THE PRIVATE COMPANY, FLORIDA GULF ENVIRONMENTAL, TO ACQUIRE THE MUD HILL LANDFILL AND THE FUTURE OPERATION THEREOF.

THE CHAIRMAN THEN ADDRESSED THE PEOPLE IN ATTENDANCE.

THE FOLLOWING PEOPLE CAME TO THE PODIUM TO ADDRESS THE BOARD AND THE AUDIENCE: HOWARD LOVETT, REPRESENTING WASHINGTON COUNTY CONCERNED CITIZENS; TOM MOODY, REPRESENTING THE FLORIDA DEPARTMENT OF ENVIRONMENTAL REGULATIONS; BOB WELLS; PAUL DICKINSON; JERRY ELLIS; MONICA CORSO; KEN HOFFMAN, ESQUIRE, RETAINED BY WASHINGTON COUNTY CONCERNED CITIZENS; MRS. DORIS HUSAK; AND AUDREY WALKER.

ROGER D. HAGAN, BOARD ADMINISTRATOR, THEN ADDRESSED THE AUDIENCE CONCERNING STATE REQUIREMENTS CONCERNING SOLID WASTE AS AFFECTED BY RECENT 1988 STATE LEGISLATION.
