BOARD MINUTES FOR 04/17/89

APRIL 17, 1989

PURSUANT TO A SPECIAL CALL, THE BOARD OF COUNTY COMMISSIONERS IN AND FOR WASHINGTON COUNTY, FLORIDA, MET ON THE ABOVE DATE AT 9:00 A. M., IN THEIR REGULAR MEETING PLACE IN THE COUNTY ADMINISTRATIVE BUILDING IN CHIPLEY, FLORIDA, WITH COMMISSIONERS CORBIN, ALBERT DAVIS, JOSH DAVIS, AND TRACY IN ATTENDANCE AND COMMISSIONER COOK ABSENT DUE TO ILLNESS. THE ATTORNEY, AND DEPUTY CLERK, MELISSA ALFORD, WERE ALSO IN ATTENDANCE.

THE MEETING WAS CALLED TO ORDER BY THE CHAIRMAN AND PRAYER WAS OFFERED BY ROGER D. HAGAN, BOARD ADMINISTRATOR.

THE PURPOSE OF THIS MEETING WAS TO DISCUSS FIRE PROTECTION FOR THE INCORPORATED AND UNINCORPORATED AREAS OF VERNON AND THE STATUS OF THE VERNON VOLUNTEER FIRE DEPARTMENT AND THE CITY OF VERNON IN REGARDS TO THE ABILITY TO PROVIDE FIRE PROTECTION SERVICE TO THE VERNON AREA. THE FOLLOWING PEOPLE ADDRESSED THE BOARD CONCERNING THIS MATTER: JERRY ELLIS, VERNON CITY COUNCILMAN AND SPOKESMAN FOR THE CITY OF VERNON, JAMES BOSWELL, PRESIDENT OF THE VERNON VOLUNTEER FIRE DEPARTMENT, LEWIS ROPER, FOREST AREA SUPERVISOR FOR THE DIVISION OF FORESTRY, KEVIN PARKER, CHIEF OF THE CHIPLEY VOLUNTEER FIRE DEPARTMENT, CHARLES KOLMETZ, CHIEF OF THE GREENHEAD VOLUNTEER FIRE DEPARTMENT, DANNY KOLMETZ, MEMBER OF THE VERNON VOLUNTEER FIRE DEPARTMENT, SHERIFF FRED PEEL, HAROLD SAPP, MAYOR OF VERNON, AL PYFROM, WASHINGTON COUNTY EMERGENCY MANAGEMENT DIRECTOR AND ROGER D. HAGAN, BOARD ADMINISTRATOR. GERALD HOLLEY, COUNTY ATTORNEY, INFORMED THE BOARD THAT THE COUNTY WOULD NEED TO MAKE A DECISION WHETHER TO CONTRACT WITH THE CITY OF VERNON OR THE VERNON VOLUNTEER FIRE DEPARTMENT FOR FIRE PROTECTION FOR THE RESIDENTS OF THE UNINCORPORATED AREA OF VERNON. MAYOR SAPP INFORMED THE BOARD THAT THE CITY OF VERNON WOULD PROVIDE FIRE PROTECTION TO SAID RESIDENTS OF THE UNINCORPORATED AREA AND THAT RESPONDING FIRE FIGHTERS OF BOTH THE CITY OF VERNON AND THE VERNON VOLUNTEER FIRE DEPARTMENT WOULD HAVE ACCESS TO THE FIRE FIGHTING EQUIPMENT UNTIL SAID MATTER COULD BE RESOLVED. COMMISSIONER CORBIN OFFERED A MOTION, SECONDED BY COMMISSIONER ALBERT DAVIS AND UNANIMOUSLY PASSED BY THE BOARD TO TABLE ANY BOARD ACTION ON SAID MATTER UNTIL THE REGULAR MEETING OF APRIL 20, 1989.

THERE BEING NO FURTHER BUSINESS AT THIS TIME, THE MEETING ADJOURNED.
