PURSUANT TO A SPECIAL CALL, THE BOARD OF COUNTY COMMISSIONERS IN AND FOR WASHINGTON COUNTY, FLORIDA, MET ON THE ABOVE DATE AT 7:00 P. M., AT THE EBRO TOWN HALL, EBRO, FLORIDA, WITH COMMISSIONERS COOK, JOSH DAVIS, AND TRACY IN ATTENDANCE AND COMMISSIONERS CORBIN AND ABSENT. DEPUTY CLERK, MELISSA ALFORD, WAS ALSO IN

THE CHAIRMAN CALLED THE MEETING TO ORDER AND LED THE PLEDGE OF ALLEGIANCE TO THE FLAG. PRAYER WAS OFFERED BY ROGER D. HAGAN, BOARD ADMINISTRATOR.

THE CHAIRMAN EXTENDED HIS APPRECIATION TO THE TOWN OF EBRO FOR ALLOWING THE BOARD TO CONDUCT THIS MEETING AT THE EBRO TOWN HALL AND ASKED IF ANYONE IN THE AUDIENCE HAD ANY QUESTIONS OR COMMENTS FOR THE BOARD AND AS NO ONE HAD ANY PURPOSE TO ADDRESS THE BOARD AT THIS TIME THE BOARD ADRESSED A FEW ITEMS OF REGULAR

SCOTT PITTS, REPRESENTING CAMP OMNI, PRESENTED A PLAT OF LAKE GENESIS ESTATES, AND ACTING UPON THE RECOMMENDATION OF THE WASHINGTON COUNTY PLANNING COMMISSION, COMMISSIONER JOSH DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND

UNANIMOUSLY PASSED BY THE BOARD, TO APPRÓVE AND ACCEPT SAID PLAT.
PURSUANT TO THE DISCOVERY OF ASBESTOS MATERIAL IN THE OLD HOSPITAL BUILDING, WHICH IS CURRENTLY BEING OCCUPIED AND PURCHASED BY THE WASHINGTON-HOLMES ASSOCIATION FOR RETARDED CITIZENS AND PURSUANT TO RECENT ACTIONS BY SAID ASSOCIATION CONCERNING THE REMOVAL OF SAID ASBESTOS MATERIAL, COMMISSIONER COOK OFFERED A MOTION, SECONDED BY COMMISSIONER JOSH DAVIS AND UNANIMOUSLY PASSED BY THE BOARD, TO AUTHORIZE GERALD HOLLEY, COUNTY ATTORNEY, TO RESEARCH ANY POSSIBLE LIABILITY, BY THE BOARD, CONCERNING SAID ASBESTOS REMOVAL AND AUTHORIZING THE CHAIRMAN TO CORRESPOND, ON BEHALF OF THE BOARD, WITH THE ASSOCIATION TO INFORM THAT THE BOARD DOES NOT CONCUR WITH THE ASSOCIATION'S PRESENT PLAN TO HAVE SAID ASBESTOS MATERIAL REMOVED.

SAID FACILITY AND HAD MET WITH JACKIE DYKES, ADMINISTRATOR, OF SAID FACILITY AND WAS SATISFIED WITH THE OPERATION OF THE CONVALESCENT CENTER. THE CHAIRMAN ALSO SUBMITTED A "NURSING HOME PROFILE" WHICH COMPARES THE OPERATION OF SAID FACILITY WITH OTHER CONVALESCENT CENTERS IN THE STATE.
