BOARD MINUTES FOR 02/27/90

FEBRUARY 27, 1990

PURSUANT TO A RECESS, THE BOARD OF COUNTY COMMISSIONERS IN AND FOR WASHINGTON COUNTY, FLORIDA, MET ON THE ABOVE DATE AT 5:00 P. M., IN THEIR REGULAR MEETING PLACE IN THE COUNTY ADMINISTRATIVE BUILDING IN CHIPLEY, FLORIDA, WITH COMMISSIONERS COOK, CORBIN, ALBERT DAVIS AND JOSH DAVIS IN ATTENDANCE AND COMMISSIONER TRACY ARRIVING AT A LATER TIME DURING THE MEETING. DEPUTY CLERK, MELISSA ALFORD, WAS ALSO IN ATTENDANCE, AND EARNESTINE MILLER, CLERK AD INTERIM, WAS ALSO IN ATTENDANCE LATER IN THE MEETING.

DUE TO THE LATE ARRIVAL OF THE CHAIRMAN, COMMISSIONER JOSH DAVIS, VICE CHAIRMAN, ASSUMED THE CHAIR AND CALLED THE MEETING TO ORDER.

THE PURPOSE OF THIS MEETING WAS TO MEET JOINTLY WITH THE WASHINGTON COUNTY PLANNING COMMISSION TO REVIEW PROPOSED CHANGES TO THE WASHINGTON COUNTY SUBDIVISION REGULATION ORDINANCE.

BEFORE SAID REVIEW OF CHANGES TO THE SUBDIVISION REGULATION ORDINANCE, STAN PORTER, REPRESENTING CANYON SPRINGS RESORT, REQUESTED THAT THE BOARD GRANT A VARIANCE TO THE SUBDIVISION REGULATION ORDINANCE WHICH WOULD REQUIRE PUBLIC ACCESS TO THE LAKE IN CANYON SPRINGS RESORT AND AFTER DISCUSSION BETWEEN THE BOARD AND MEMBERS OF THE PLANNING COMMISSION TO DETERMINE IF THERE WERE ANY OBJECTIONS TO THE BOARD GRANTING SAID VARIANCE, COMMISSIONER ALBERT DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER CORBIN AND UNANIMOUSLY PASSED BY THE BOARD, TO GRANT SAID VARIANCE, CONTINGENT THAT THE LAKE IN CANYON SPRINGS RESORT IS NOT LATER NAMED AS A PUBLIC RECREATION AREA IN WASHINGTON COUNTY'S COMPREHENSIVE PLAN, AND IF SO, PUBLIC ACCESS TO SAID LAKE WOULD THEN BE NEGOTIATED BETWEEN THE COUNTY AND CANYON SPRINGS RESORT, INCORPORATED.

AT THIS TIME, RANDY PARKER, WASHINGTON COUNTY CONSULTANT FOR IT'S COMPREHENSIVE PLAN, ADDRESSED THE BOARD CONCERNING THE TIME SCHEDULE FOR COMPLETION OF SAID COMPREHENSIVE PLAN AND ALSO REVIEWED THE PROPOSED CHANGES TO WASHINGTON COUNTY'S SUBDIVISION REGULATION ORDINANCE FOR CONSIDERATION BY THE BOARD AND THE WASHINGTON COUNTY PLANNING COMMISSION.

ACTING UPON THE RECOMMENDATION OF ROGER D. HAGAN, COUNTY ADMINISTRATOR, COMMISSIONER COOK OFFERED A MOTION, SECONDED BY COMMISSIONER ALBERT DAVIS AND UNANIMOUSLY PASSED BY THE BOARD, TO DENY A REQUEST BY KEN TRAWICK TO LIFT WEIGHT RESTRICTIONS ON CR 276 AND CR 276A TO HWY 277.

COMMISSIONER ALBERT DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER CORBIN AND UNANIMOUSLY PASSED BY THE BOARD, TO ADOPT A RESOLUTION TO APPLY FOR A EMERGENCY MEDICAL SERVICES GRANT.
