BOARD MINUTES FOR 04/04/91

APRIL 4, 1991

THE WASHINGTON COUNTY BOARD OF COUNTY COMMISSIONERS MET ON THE ABOVE DATE AT 5 P. M. IN SPECIAL SESSION AT THE CHIPLEY CITY HALL, CHIPLEY, FLORIDA. COMMISSIONERS TAYLOR, CORBIN, TRACY AND DAVIS WERE PRESENT WITH COMMISSIONER COOK ABSENT. CLERK EARNESTINE MILLER AND ADMINISTRATIVE SECRETARY, VONCILE ESTES WERE ALSO PRESENT.

THE MEETING WAS PROCLAIMED BY CHAIRMAN CORBIN. CHAIRMAN CORBIN LED THE PLEDGE OF ALLEGIANCE TO THE FLAG WITH COMMISSIONER TRACY OFFERING PRAYER.

THE PURPOSE OF THE SPECIAL CALLED MEETING WAS TO CONDUCT A PUBLIC HEARING TO SOLICIT PUBLIC COMMENT ON THE WASHINGTON COUNTY COMPREHENSIVE PLAN IN ACCORDANCE WITH THE FLORIDA DEPARTMENT OF COMMUNITY AFFAIRS OBJECTIONS, RECOMMENDATIONS AND COMMENTS REPORT AND TO ADOPT AN ORDINANCE ACCEPTING THE COMPREHENSIVE PLAN.

CHAIRMAN CORBIN OPENED THE FLOOR FOR QUESTIONS FROM THE AUDIENCE ON THE COMPREHENSIVE PLAN. MR. HOMER RUDD EXPRESSED HIS CONCERN ON THE SILVER CULTURE OPERATIONS, ABOUT CUTTING TREES CLOSE TO THE WATER. HE ALSO QUESTIONED WHAT WAS CONSIDERED WET LANDS, AND QUESTIONED THE DENSITY. MR. RUDD ALSO ASKED HOW THE SUB-STANDARD HOUSING WAS GOING TO BE HANDLED. MR. RANDY PARKER, THE CONSULTANT ON THE COMPREHENSIVE PLAN, RESPONDED TO MR. RUDD'S QUESTIONS.

MR. RANDY PARKER THEN PRESENTED A REPORT SHOWING THE CHANGES TO BE MADE TO THE COMPREHENSIVE PLAN.

A MOTION TO ADOPT THE ORDINANCE ADOPTING THE COMPREHENSIVE PLAN WAS MADE BY COMMISSIONER DAVIS, SECONDED BY COMMISSIONER TAYLOR AND CARRIED UNANIMOUSLY.
