THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 9:00 A. M. AT THE CHIPLEY CITY HALL, CHIPLEY, FLORIDA, IN EMERGENCY SESSION WITH COMMISSIONERS CORBIN, TAYLOR, TRACY, COOK AND DAVIS PRESENT. ATTORNEY HOLLEY AND DEPUTY CLERK DIANNE CARTER WERE ALSO IN ATTENDANCE.

ADMINISTRATOR HAGAN PROCLAIMED THE MEETING. CHAIRMAN CORBIN CALLED THE MEETING TO ORDER WITH ADMINISTRATOR HAGAN OFFERING PRAYER AND ATTORNEY HOLLEY LEADING THE PLEDGE OF ALLEGIANCE TO THE FLAG.

THE PURPOSE OF THE EMERGENCY SESSION WAS TO TAKE ACTION ON AN EMERGENCY REQUEST RESOLUTION, HEALTH DEPARTMENT TRUST FUND, DISPO- SITION OF FINAL ORDER IN SHERIFF'S BUDGET APPEAL AND ADVISE OF A COMP PLAN PRESS RELEASE.

COMMISSIONER COOK OFFERED A MOTION, SECONDED BY COMMISSIONER DAVIS AND CARRIED TO AUTHORIZE THE CHAIRMAN TO SIGN THE EMERGENCY GRANT REQUEST RESOLUTION IN ORDER TO APPLY FOR CDBG DISASTER GRANT FUNDS TO ASSIST WITH ROAD MAINTENANCE DUE TO THE EFFECTS OF THE FLOOD DAMAGE.

RSOLUTION ON GRANT APPLICATION

ADMINISTRATOR HAGAN ADVISED THE BOARD THERE WAS A POSSIBILITY THE GOVERNOR WOULD TAP ALL TRUST FUNDS AT STATE LEVEL IN SPECIAL SESSION ON THE 6TH OF JUNE. THE WASHINGTON COUNTY HEALTH DEPARTMENT HAS A TRUST FUND OF \$175,000 ESTABLISHED FOR PRE-NATAL CARE AND ADMINISTRATOR HAGAN RECOMMENDED THE BOARD GET THE PROJECT UNDERWAY BY ALLOWING BUILDING MAINTENANCE SUPERVISOR, TOBE RUSS, TO ESTABLISH BATTER BOARDS, DIG THE FOOTER, ETC. FOR THE BUILDING. COMMISSIONER TRACY OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND CARRIED TO START THE PROJECT FOR THE ADDITION OF A PRE-NATAL CARE TO THE WASHINGTON COUNTY HEALTH DEPARTMENT, CONTINGENT UPON MONIES BEING SAVED DURING SPECIAL SESSION.

THERE WAS A DISCUSSION ON THE DISPOSITION OF THE FINAL ORDER IN THE SHERIFF'S BUDGET APPEAL, WITH ATTORNEY HOLLEY EXPLAINING THE NEXT STEPS THE BOARD COULD TAKE IN APPEALING THE DECISION OF THE GOVERNOR AND CABINET. COMMISSIONER TAYLOR OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND CARRIED NOT TO APPEAL THE DISPOSITION OF FINAL ORDER IN THE SHERIFF'S BUDGET APPEAL.

CHAIRMAN CORBIN ADVISED THE COMPREHENSIVE PLAN FOR WASHINGTON COUNTY HAS BEEN FOUND IN COMPLIANCE BY THE DEPARTMENT OF COMMUNITY AFFAIRS, BEING THE FIRST COUNTY IN THE PANHANDLE TO BE FOUND IN COMPLIANCE.
