OCTOBER 17, 1991

THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 9:00 A. M. AT THE CHIPLEY CITY HALL, CHIPLEY, FLORIDA, WITH COMMISSIONERS DAVIS, CORBIN, TAYLOR AND COOK PRESENT ANDCOMMISSIONER TRACY ABSENT. ATTORNEY HOLLEY, CLERK EARNESTINE MILLER AND DEPUTY CLERK DIANNE CARTER WERE ALSO PRESENT.

ADMINISTRATOR HAGAN PROCLAIMED THE MEETING. CHAIRMAN CORBIN CALLED THE MEETING TO ORDER WITH REV. GARY WIGGINS OF THE SHILOH BAP- TIST CHURCH OFFERING PRAYER. ATTORNEY HOLLEY LED THE PLEDGE OF ALLEGIANCE TO THE FLAG.

COMMISSIONER DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND CARRIED TO ADOPT THE MINUTES OF THE SEPTEMBER 16, 19, 26 MEETINGS AND THE SEPTEMBER 27 MINUTES OF THE PROPERTY APPRAISAL ADJUSTMENT BOARD MEETING.

MRS. WANDA PRIBBLE ADDRESSED THE BOARD ON A PROBLEM OF LOUD MUSIC AND OTHER DISTURBANCES COMING FROM THE CARYVILLE 279 BOTTLE CLUB AS WELL AS A TRAILER LOCATED ACROSS THE CREEK FROM THE BOTTLE CLUB. MR. MCCOY AND V. M. HOWELL ALSO SPOKE TO THE BOARD ON THE PROBLEM OF THE DISTURBANCES. COMMISSIONER DAVIS AND ATTORNEY HOLLEY ARE TO LOOK OVER THE BOTTLE CLUB ORDINANCE TO SEE IF CHANGES CAN BE MADE TO THE ORDINANCE TO REGULATE THE NOISE PROBLEM.

MR. CHUCK YATES COMPLIMENTED COMMISSIONER CORBIN AND ADMINISTRATOR HAGAN FOR THEIR QUICK SERVICE ON REPAIRING A HAZARDOUS ROAD CONDITION HE HAD CONTACTED THEM ABOUT. MR. YATES ALSO STATED HE OBJECTED TO THE HAZARDOUS CONDITIONS OF THE COUNTY ROADS SAYING THEY EXPOSED THE TAX PAYERS TO LIABILITY AND INCONVENIENCE.

MR. JIMMY BAILEY WAS PRESENT TO RECEIVE A REPLY CONCERNING THE BOARD PLACING A REFERENDUM ON THE MARCH BALLOT ALLOWING THE CITIZENS OF WASHINGTON COUNTY TO DECIDE IF THEY WANT TO ELECT COUNTY COMMISSIONERS BY SINGLE DISTRICT OR AT LARGE. ATTORNEY HOLLEY ADVISED IN ORDER FOR A REFERENDUM TO BE PLACED ON THE BALLOT, IT WOULD REQUIRE BOARD ACTION AND THE SANCTIONS OF JUDGE VINSON. MR. BAILEY ADVISED THE BOARD HE WOULD HAVE TO GO THROUGH THE PETITION PROCESS IF THEY DIDN'T TAKE ACTION AT THIS TIME. THE BOARD AGREED NOT TO TAKE ACTION UNTIL THE ENTIRE BOARD WAS PRESENT TO VOICE THEIR OPINION.

COMMISSIONER COOK OFFERED A MOTION, SECONDED BY COMMISSIONER DAVIS AND CARRIED TO APPOINT MS. JOSEPHINE ROBINSON TO THE DISTRICT 2 MENTAL HEALTH PLANNING BOARD CONTINGENT ON MS. ROBINSON ACCEPTING THE POSITION. MS. ROBINSON WOULD BE REPLACING MS. MARGARET BROCK.

CHUCK YATES RECOMMENDED THE BOARD WAIT UNTIL THE JAIL COMMITTEE IS FINISHED WITH THEIR REPORT PRIOR TO MAKING ANY DECISIONS. ADMINISTRATOR HAGAN IS TO CHECK AND SEE WHERE

THE MONIES ARE GOING TO COME FROM AND REPORT BACK TO THE BOARD. ADMINISTRATOR HAGAN IS ALSO TO NOTIFY CALHOUN COUNTY AND JACKSON COUNTY THE BILLS FOR HOUSING THE INMATES WOULD BE PAID AT THE NOVEMBER BOARD MEETING.
