BOARD MINUTES FOR 09/16/91

SEPTEMBER 16, 1991

PURSUANT TO CHAPTER 129 AND 200, FLORIDA STATUTES, REQUIRING THE FIRST PUBLIC HEARING TO DETERMINE THE MILLAGE AND ADOPT THE BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1992, THE BOARD OF COUNTY COMMISSIONERS IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 5:05 P. M. AT THE CHIPLEY CITY HALL, CHIPLEY, FLORIDA WITH COMMISSIONERS COOK, DAVIS, TAYLOR, TRACY, AND CORBIN PRESENT. ATTORNEY HOLLEY, CLERK EARNESTINE MILLER AND DEPUTY CLERK DIANNE CARTER WERE ALSO IN ATTENDANCE.

COUNTY ADMINISTRATOR ROGER HAGAN PROCLAIMED THE MEETING. CHAIR- MAN CORBIN CALLED THE MEETING TO ORDER WITH ADMINISTRATOR HAGAN OFFERING PRAYER. ATTORNEY HOLLEY LED THE PLEDGE OF ALLEGIANCE TO THE FLAG.

CHAIRMAN CORBIN STATED THE PURPOSE OF THE MEETING WAS TO ADOPT A MILLAGE RATE AS THE TENTATIVE MILLAGE RATE AND TO ADOPT A TENTATIVE BUDGET FOR FISCAL YEAR ENDING SEPTEMBER 30, 1992. HE ADVISED EVERY PROPERTY OWNER IN WASHINGTON COUNTY WAS NOTIFIED OF THE MEETING BY THE REQUIRED "TRIM" NOTICES.

THE CHAIRMAN ASKED IF ANYONE IN THE AUDIENCE WISHED TO ASK ANY QUESTIONS OR MAKE ANY COMMENTS CONCERNING THE PROPOSED MILLAGE RATE OR PROPOSED BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1992. MR. CHUCK YATES SPOKE CONCERNING THE BOARD NOT FUNDING THE TRI-COUNTY AIRPORT AUTHORITY STATING THEY COULD NOT OPERATE WITHOUT FINANCIAL ASSISTANCE FROM THE COUNTIES. HE STATED HE WOULD HAVE TO WRITE A LETTER TO THE GOVERNOR REQUESTING THE AIRPORT BE CLOSED FOR LACK OF FINANCING IF THE OTHER COUNTIES DID AS WASHINGTON COUNTY.

MR. B. L. HILL OF SUNNY HILLS ADDRESSED THE BOARD ON CENTRAL PURCHASING.

MR. WALLACE BRANNON QUESTIONED SOME OF THE REVENUE ESTIMATES USED THIS YEAR IN COMPARISON TO LAST YEAR.

COMMISSIONER DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND UNANIMOUSLY PASSED BY THE BOARD ON EACH OF THEIR AFFIRMATIVE VOTE, TO ADOPT A MILLAGE RAGE OF 10.00 MILLS AS THE TENTATIVE MILLAGE RATE FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1992.

ADMINISTATOR HAGAN BRIEFED THE BOARD ON THE CHANGES TO THE BUDGET SINCE THE AUGUST 20TH WORKSHOP DUE TO THE ESTIMATED CASH CARRY FORWARD PROVIDED BY THE AUDITOR.

COMMISSIONER TAYLOR OFFERED A MOTION, SECONDED BY COMMISSIONER DAVIS AND UNANIMOUSLY PASSED BY THE BOARD ON EACH OF THEIR AFFIRMATIVE VOTE, THE PROPOSED BUDGET BE ADOPTED AS THE TENTATIVE BUDGET FOR FISCAL YEAR ENDING SEPTEMBER 30, 1992.
