MR. LOUIS ROPER AND MR. CHARLES REEVES BRIEFED THE BOARD ON THE INFORMATION IN THE ANNUAL FORESTRY REPORT. COMMISSIONER COOK OFFERED A MOTION, SECONDED BY COMMISSIONER TRACY AND CARRIED TO ADOPT THE ANNUAL REPORT OF THE WASHINGTON COUNTY COOPERATIVE FORESTER ASSISTANCE PROJECT FOR THE MINUTES.
