SEPTEMBER 27, 1991

THE PROPERTY APPRAISAL ADJUSTMENT BOARD IN AND FOR WASHINGTON COUNTY, FLORIDA, MET ON THE ABOVE DATE AT 9:00 A. M. AT THE DISTRICT SCHOOL BOARD CONFERENCE ROOM AT 206 NORTH 3RD STREET, CHIPLEY, FLORIDA, WITH HONORABLE JOSH DAVIS, HONORABLE LOUIS TRACY, AND HONORABLE DOYLE TAYLOR REPRESENTING THE BOARD OF COUNTY COMMISSIONERS AND THE HONORABLE LARRY ENFINGER AND HONORABLE MARGARET GILMORE REPRESENTING THE WASHINGTON COUNTY SCHOOL BOARD, PRESENT AND SEATED AS THE BOARD. EARNESTINE MILLER, CLERK OF THE CIRCUIT COURT AND DIANNE CARTER, DEPUTY CLERK, WERE ALSO PRESENT. GERALD HOLLEY, COUNTY ATTORNEY, WAS PRESENT IN HIS OFFICIAL CAPACITY. THE HONORABLE RONALD WRIGHT, PROPERTY APPRAISER, WAS PRESENT TO SERVE IN HIS OFFICIAL CAPACITY.

THE HONORABLE DOYLE TAYLOR SERVED AS CHAIRMAN OF THIS BOARD.

THE MEETING WAS CALLED TO ORDER BY CHAIRMAN TAYLOR WITH ATTORNEY HOLLEY OFFERING PRAYER AND LEADING IN THE PLEDGE OF ALLEGIANCE TO THE FLAG.

CHAIRMAN TAYLOR INTRODUCED THE BOARD MEMBERS AND WELCOMED EVERYONE TO THE MEETING.

ATTORNEY HOLLEY EXPLAINED THE BASIC PURPOSE OF THE PROPERTY APPRAISAL ADJUSTMENT BOARD.

PETITION 15 WAS FILED BY JERRY WALSH SEEKING REVIEW AND ADJUSTMENT OF THE ASSESSED VALUE OF PARCEL NUMBER 3133.057 STATING HIS PROPERTY VALUE ALMOST DOUBLED IN VALUE SINCE LAST YEAR. COMMISSIONER TRACY OFFERED A MOTION TO DENY MR. WALSH'S REQUEST FOR AN ADJUSTMENT AND UPHOLD THE PROPERTY APPRAISER'S ASSESSMENT OF THE PROPERTY, SCHOOL BOARD MEMBER LARRY ENFINGER SECONDED THE MOTION AND IT CARRIED UNANIMOUSLY.
