BOARD MINUTES FOR 07/02/92

JULY 2, 1992

PURSUANT TO A RECESS FROM THE JUNE 19, 1992 MEETING, THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 10:00 A. M. AT THE WASHINGTON COUNTY ADMINISTRATIVE BUILDING, 201 WEST CYPRESS AVENUE, CHIPLEY, FLORIDA, WITH COMMISSIONERS CORBIN, TAYLOR, TRACY, DAVIS AND COOK PRESENT. ATTORNEY HOLLEY, CLERK EARNESTINE MILLER AND DEPUTY CLERK DIANNE CARTER WERE ALSO IN ATTENDANCE.

CHAIRMAN CORBIN CALLED THE MEETING TO ORDER WITH ATTORNEY HOLLEY OFFERING PRAYER. CHAIRMAN CORBIN LED IN THE PLEDGE OF ALLEGIANCE TO THE FLAG.

CHAIRMAN CORBIN EXPLAINED THE PURPOSE OF THE RECESSED MEETING WAS TO MEET IN JOINT SESSION WITH THE WASHINGTON COUNTY PLANNING COMMISSION ADDRESSING THE PROPOSED CHANGES OF SECTION 10.05.00 TITLED "SPECIAL EXCEPTIONS" OF THE LAND DEVELOPMENT CODE.

CHAIRMAN CORBIN THEN TURNED THE MEETING OVER TO HULAN CARTER, CHAIRMAN OF THE WASHINGTON COUNTY PLANNING COMMISSION, FOR HIM TO PROCEED WITH THEIR PUBLIC HEARING ON THE PROPOSED "SPECIAL EXCEPTIONS" CHANGES. RANDY PARKER, CONSULTANT ON THE COMPREHENSIVE PLAN, PRESENTED THE BOARD WITH A COPY OF THE PROPOSED CHANGES TO BE MADE AS WELL AS EXPLAINED THE PURPOSE FOR THE CHANGES. (A COPY IS ATTACHED.) THE PLANNING COMMISSION CONCLUDED THEIR PUBLIC HEARING AND TURNED THE MEETING OVER TO CHAIRMAN CORBIN.

COMMISSIONER TRACY OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND CARRIED TO ACCEPT THE RECOMMENDATIONS OF THE PLANNING COMMISSION AND ACCEPT THE PROPOSED LANGUAGE CHANGES TO THE "SPECIAL EXCEPTIONS" OF THE LAND DEVELOPMENT CODE. THE BOARD AGREED TO ADVERTISE FOR A PUBLIC HEARING ON THE PROPOSED CHANGES TO THE "SPECIAL EXCEPTIONS" OF THE LAND CODE TO BE HELD ON JULY 16, 1992 AT 10:00 A. M. AT THE COUNTY ADMINISTRATIVE BUILDING.
