BOARD MINUTES FOR 09/15/92

SEPTEMBER 15, 1992

THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 5:05 P. M., AT THE WASHINGTON COUNTY ADMINISTRATIVE BUILDING, 201 WEST CYPRESS AVENUE, CHIPLEY, FLORIDA, WITH COMMISSIONERS CORBIN, TRACY, COOK, DAVIS AND TAYLOR PRESENT. ATTORNEY HOLLEY, CLERK EARNESTINE MILLER AND DEPUTY CLERKS DIANNE CARTER AND JOHNNIE ODOM WERE ALSO IN ATTENDANCE.

ADMINISTRATOR ROGER HAGAN PROCLAIMED THE MEETING WITH ATTORNEY HOLLEY OFFERING PRAYER AND CHAIRMAN CORBIN LEADING IN THE PLEDGE OF ALLEGIANCE TO THE FLAG.

CHAIRMAN CORBIN OPENED THE MEETING STATING THE PURPOSE OF THE MEETING WAS TO HOLD THE FIRST PUBLIC HEARING TO DETERMINE THE MILLAGE AND ADOPT THE BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1993.

CERTIFICATE OF TAXABLE VALUE

CHAIRMAN CORBIN STATED EVERY PROPERTY OWNER IN WASHINGTON COUNTY WAS NOTIFIED OF THE MEETING BY THE REQUIRED "TRIM " NOTICES.

CHAIRMAN CORBIN THEN STATED THE PROPOSED MILLAGE RATE FOR THE 1992-93 BUDGET IS 10.000 MILLS.

CHAIRMAN CORBIN ADVISED THE PROPOSED MILLAGE RATE IS 4.47 PERCENT GREATER THAN THE ROLLED-BACK RATE.

CHAIRMAN CORBIN THEN ASKED IF ANYONE IN THE AUDIENCE WISHED TO ASK ANY QUESTIONS OR MAKE ANY COMMENTS CONCERNING THE PROPOSED MILLAGE RATE OR THE PROPOSED BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1993, AND AFTER HEARING COMMENTS FROM SEVERAL CITIZENS IN ATTENDANCE, CHAIRMAN CORBIN ENTERTAINED ACTION FROM THE BOARD.

COMMISSIONER TRACY OFFERED A MOTION, SECONDED BY COMMISSIONER DAVIS AND UNANIMOUSLY PASSED BY THE BOARD ON A ROLL CALL VOTE, TO ADOPT A MILLAGE RATE OF 10.000 MILLS AS THE TENTATIVE MILLAGE RATE FOR FISCAL YEAR ENDING SEPTEMBER 30, 1993.

COMMISSIONER DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND UNANIMOUSLY PASSED BY THE BOARD ON A ROLL CALL VOTE, TO ADOPT THE PROPOSED BUDGET AS THE TENTATIVE BUDGET FOR FISCAL YEAR ENDING SEPTEMBER 30, 1993.
