#### 1992 SEPTEMBER 24

THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 5:05 P. M., IN THE WASHINGTON COUNTY ADMINISTRATIVE BUILDING, 201 WEST CYPRESS AVENUE, CHIPLEY, FLORIDA, WITH COMMISSIONERS CORBIN, TAYLOR, TRACY, COOK AND DAVIS PRESENT. CLERK EARNESTINE MILLER, DEPUTY CLERK DIANNE CARTER AND DEPUTY CLERK JOHNNIE ODOM WERE ALSO IN ATTENDANCE.

ADMINISTRATOR HAGAN PROCLAIMED THE MEETING. CHAIRMAN CORBIN OPENED THE MEETING WITH ADMINISTRATOR HAGAN OFFERING PRAYER. CHAIR- MAN CORBIN LED IN THE PLEDGE OF ALLEGIANCE TO THE FLAG.

CHAIRMAN CORBIN STATED THE MAIN PURPOSE OF THIS MEETING WAS TO HOLD THE FINAL PUBLIC HEARING FOR THE DECISION ON THE MILLAGE RATE TO BE LEVIED BY THE BOARD AND THE ADOPTION OF THE BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1993. THE FINAL HEARING WAS ADVERTISED IN THE WASHINGTON COUNTY NEWS, A NEWSPAPER OF GENERAL CIRCULATION WITHIN THE COUNTY, ON SEPTEMBER 21, 1992.

ADVERTISEMENT OF BUDGET

CHAIRMAN CORBIN STATED THE PROPOSED MILLAGE RATE IS 4.47% HIGHER THAN THE ROLLED-BACK RATE.

CHAIRMAN CORBIN THEN ASKED IF THERE WAS ANYONE IN THE AUDIENCE WHO WOULD LIKE TO COMMENT OR ASK QUESTIONS PERTAINING TO THE BUDGET FOR FISCAL YEAR 1992-93.

CHAIRMAN CORBIN RECOGNIZED MR. BILL ACUFF WHO ASKED EACH BOARD MEMBER IF THEY WERE AWARE THE WATER MANAGEMENT DISTRICT WAS HOLDING THEIR BUDGET HEARING AT THIS SAME TIME IN PANAMA CITY, FLORIDA ON THIS DATE PRIOR TO THEM SETTING THEIR BUDGET HEARING DATE. EACH COMMISSIONER RESPONDED AT THE TIME THE BUDGET HEARING FOR THE COUNTY WAS SCHEDULED FOR THIS DATE, THEY WERE UNAWARE THE WATER MANAGEMENT DISTRICT WAS HOLDING THEIR HEARING AT THE SAME TIME.

MR. ACUFF THEN QUESTIONED THE INCREASE IN THE BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1993. THE BOARD ADVISED THE INCREASE WAS MAINLY DUE TO GRANTS THEY HAVE RECEIVED.

NO ONE ELSE HAD ANY QUESTIONS OR COMMENTS ON THE BUDGET. CHAIR- MAN CORBIN STATED THE TENTATIVE MILLAGE RATE WAS TEN MILLS AND ASKED DEPUTY CLERK DIANNE CARTER TO READ THE MILLAGE RESOLUTION. COM- MISSIONER DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER COOK AND UNANIMOUSLY PASSED BY THE BOARD ON A SEPARATE VOTE OF EACH COM- MISSIONER, TO ADOPT A RESOLUTION AND TO SET THE MILLAGE FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1993 AT 10.00 MILLS.
