AUGUST 6, 1993

PURSUANT TO A RECESS FROM THE AUGUST 5, 1993 MEETING, THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 10:00 A. M. AT THE WASHINGTON COUNTY ADMINISTRATIVE BUILDING, 201 WEST CYPRESS AVENUE, CHIPLEY, FLORIDA, WITH COMMISSIONERSCORBIN, CARTER, BROCK, TAYLOR AND MORRIS PRESENT. CLERK EARNESTINE MILLER AND DEPUTY CLERK DIANNE CARTER WERE ALSO IN ATTENDANCE.

CHAIRMAN CORBIN CALLED THE RECESSED MEETING TO ORDER.

COMMISSIONER CARTER OFFERED A MOTION, SECONDED BY COMMISSIONER BROCK AND CARRIED TO ADOPT A RESOLUTION AND MAKE APPLICATION FOR AN EMS GRANT TOTALLING \$5,934.99.

COMMISSIONER CARTER OFFERED A MOTION, SECONDED BY COMMISSIONER TAYLOR AND CARRIED TO ACCEPT AND AUTHORIZE THE CHAIRMAN TO SIGN THE LEASE WITH SOIL CONSERVATION.

RONALD WRIGHT, PROPERTY APPRAISER, ADDRESSED HIS BUDGET REQUEST WITH THE BOARD EXPLAINING HIS INCREASES WERE DUE TO AMENDMENT 10. HE STATED BECAUSE OF AMENDMENT 10, HE WAS HAVING TO HIRE TWO NEW EMPLOYEES.

WRIGHT AGREED TO COMPLY WITH THE BOARD'S REQUEST TO KEEP SALARY INCREASES AT 3%.

A DISCUSSION WAS HELD ON THE PROPERTY APPRAISER NOT TURNING IN HIS EXCESS MONIES AT THE END OF THE YEAR; BUT, JUST LESSENED HIS FIRST REQUISITION FOR THE NEXT YEAR BY THIS AMOUNT. COMMISSIONER CARTER OFFERED A MOTION, SECONDED BY COMMISSIONER MORRIS AND CARRIED TO CHANGE THE PROPERTY APPRAISER'S PROCEDURE OF RETURNING EXCESS MONIES; WITH THE APPRAISER, IN THE FUTURE, TO TURN IN EXCESS MONEY RATHER THAN LESSEN HIS FIRST REQUISTION FOR THE NEXT YEAR.

THE BOARD BEGAN DISCUSSING THE BUDGET AND GOING OVER LINE ITEMS ON SOME OF THE DEPARTMENT BUDGETS. THEY REQUESTED DECREASING THE GENERAL BUILDING BUDGET BY AN ADDITIONAL \$20,700.00.
