## OCTOBER 4, 1995

THE BOARD OF COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 9:00 A. M. AT THE WASHINGTON COUNTY ADMINISTRATIVE BUILDING, 711 THIRD STREET, CHIPLEY, FLORIDA WITH COMMISSIONERS CORBIN, BROCK, MORRIS AND DAVIS PRESENT. CLERK EARNESTINE MILLER, ADMINISTRATOR ROGER HAGAN AND DEPUTY CLERK DIANNE CARTER WERE ALSO IN ATTENDANCE.

CHAIRMAN CORBIN CALLED THE EMERGENCY MEETING TO ORDER. THE MEETING WAS CALLED DUE TO THE WEATHER CONDITIONS RELATED TO HURRICANE OPAL.

ADMINISTRATOR HAGAN BRIEFED THE BOARD ON THE STATUS OF HURRICANE OPAL AND ADVISED OF THE EVACUATION SHELTERS THAT WOULD BE OPEN.

CHAIRMAN CORBIN READ THE STATE OF LOCAL EMERGENCY RESOLUTION. COMMISSIONER MORRIS OFFERED A MOTION, SECONDED BY COMMISSIONER DAVIS AND CARRIED UNANIMOUSLY TO ADOPT THE STATE OF LOCAL EMERGENCY RESOLUTION DUE TO HURRICANE OPAL.

SHERIFF HASTY ADDRESSED THE BOARD STATING HE HAD TAKEN CARE OF HIS FUEL CONCERNS AND THE FARMERS MARKET IN BONIFAY WOULD BE AN AVAILABLE SHELTER FOR RESIDENTS OF CARYVILLE.

DISCUSSION WAS HELD ON BAY COUNTY STOPPING THE SALE OF ALCOHOL. COMMISSIONER DAVIS OFFERED A MOTION, SECONDED BY COMMISSIONER MORRIS AND CARRIED TO PROHIBIT THE SALE OF ALCOHOLIC BEVERAGES IN WASHINGTON COUNTY FROM 6:00 P. M. OCTOBER 4, 1995 TO 6:00 A. M. OCTOBER 5, 1995.

LEON SEXTON, EMERGENCY MANAGEMENT DIRECTOR, BRIEFED THE BOARD ON OPAL AND ADVISED ADDITIONAL SHELTERS CAN BE OPENED ON AN AS NEEDED BASIS. HE REQUESTED CHAIRMAN CORBIN BE AVAILABLE IN CASE HE WAS NEEDED.

DAVID SOLGER ADDRESSED HIS CONCERN WITH THE ROOF AT THE AG CENTER AND QUESTIONED USING IT FOR A SHELTER. THE BOARD AGREED NOT TO HAVE THE AG CENTER AUDITORIUM OPEN FOR SHELTER IF IT IS UNSAFE.

SHERIFF HASTY REQUESTED STAN PORTER, PRESIDENT OF FIREMENS ASSOCIATION, COORDINATE WITH THE FIRE DEPARTMENTS TO WORK WITH HIM AND THE EMERGENCY MANAGEMENT DIRECTOR.

PATSY JUSTICE, WASHINGTON COUNTY HEALTH DEPARTMENT, SAID AUXILLARY POWER WOULD BE NEEDED AT THE COUNCIL ON AGING. SEXTON AGREED TO GET THE NECESSARY GENERATORS FOR EMERGENCY FACILITIES.
