

BOARD MINUTES FOR 10/19/04

OCTOBER 19, 2004

THE VALUE ADJUSTMENT BOARD FOR WASHINGTON COUNTY MET ON THE ABOVE DATE AT 9:00 A.M. AT THE WASHINGTON COUNTY ANNEX, BOARD MEETING ROOM, 1331 SOUTH BOULEVARD, CHIPLEY, FLORIDA WITH COUNTY COMMISSION BOARD MEMBERS RONNIE FINCH, LYNN COPE, LENZY CORBIN AND SCHOOL BOARD MEMBER GARY CLARK PRESENT. PHILLIP ROUNTREE, SCHOOL BOARD MEMBER, WAS NOT PRESENT FOR THE MEETING. ATTORNEY GERALD HOLLEY AND DEPUTY CLERK DIANNE CARTER WERE ALSO IN ATTENDANCE.

COMMISSIONER FINCH NOMINATED BOARD MEMBER LENZY CORBIN TO SERVE AS CHAIRMAN OF THE BOARD, COMMISSIONER COPE SECONDED THE MOTION AND IT CARRIED.

CHAIRMAN CORBIN ASKED PROPERTY APPRAISER GIL CARTER TO ADDRESS PETITION # 7 FILED BY DARREN BRUMLEY AND LORI BACINO SEEKING AN APPEAL OF LATE FILING OF AGRICULTURAL CLASSIFICATION FOR EXTENUATING CIRCUMSTANCES.

PROPERTY APPRAISER CARTER UPDATED THE BOARD ON THE PETITION FILED BY BRUMLEY AND BACINO LISTED THE REASON FOR LATE FILING WAS DUE TO THEIR NOT FILING BEFORE AND WERE NOT AWARE OF THE DEADLINE. HE HAD SENT THE PETITIONERS A QUESTIONNAIRE ASKING IF THE PROPERTY WAS USED AS AGRICULTURE; HE HASN'T RECEIVED A RESPONSE.

ATTORNEY HOLLEY ADVISED THE BOARD THERE WAS JUSTIFICATION FOR THEM TO DENY THE PETITION BASED ON THE PETITIONER'S FAILURE TO REPLY TO THE PROPERTY APPRAISER'S REQUEST FOR INFORMATION.

BOARD MEMBER CLARK OFFERED A MOTION, SECONDED BY BOARD MEMBER COPE AND CARRIED TO DENY THE APPEAL FOR LATE FILING OF AN AGRICULTURAL CLASSIFICATION BY DAREN BRUMLEY AND LORI BACINO.

BOARD MEMBER CLARK OFFERED A MOTION, SECONDED BY BOARD MEMBER FINCH AND CARRIED TO ADJOURN THE VALUE ADJUSTMENT BOARD MEETING.
