THE BOARD OF COUNTY COMMISSIONERS, IN AND FOR WASHINGTON COUNTY, MET ON THE ABOVE DATE AT 9:00 A.M. AT THE WASHINGTON COUNTY ANNEX, BOARD MEETING ROOM, 1331 SOUTH BOULEVARD, CHIPLEY, FLORIDA WITH COMMISSIONERS PATE, BROCK, STRICKLAND, HOWELL AND HOLMAN PRESENT. EMORY PITTS, COUNTY MANAGER, LINDA COOK, CLERK AND DIANNE GLASGOW, DEPUTY CLERK WERE ALSO IN ATTENDANCE.

CHAIRMAN HOLMAN CALLED THE MEETING TO ORDER. COMMISSIONER PATE OFFERED PRAYER WITH COMMISSIONER HOWELL LEADING IN THE PLEDGE OF ALLEGIANCE.

CHAIRMAN HOLMAN ASKED IF A DECISION HAS BEEN MADE ON THE HEALTH INSURANCE. MR. PITTS UPDATED THE BOARD ON DEPUTY CLERK GLASGOW HAVING PROVIDED EACH OF THEM WITH BUDGET NOTES; THE BUDGET IS BALANCED AT THE ROLL BACK RATE WITH THE INSURANCE REMAINING THE SAME AS WE HAVE NOW, THE COMMISSIONERS PAYING THE SAME AS THEY ARE PAYING IN THE CURRENT YEAR FOR DEPENDENT CARE AND THE SHERIFF'S DEPARTMENT'S BUDGET IS FUNDED THE SAME AS THE CURRENT YEAR. THE INCREASE TO THE COUNTY COMMISSION BUDGET FOR THE SHERIFF DEPARTMENT'S HEALTH INSURANCE IS \$56,344.

SHERIFF HADDOCK WAS PRESENT AND QUESTIONED WHAT THE BOARD IS GOING TO DO ON THE FUNDING OF THE DEPENDENT HEALTH INSURANCE.

COMMISSIONER HOWELL ASKED IF THE BUDGET IS BALANCED USING THE ROLL BACK RATE OF 9.0913. DEPUTY CLERK GLASGOW ADVISED IT WAS.

COMMISSIONER STRICKLAND SAID, WHEN THE BOARD STARTED PAYING 75% OF DEPENDENT HEALTH COVERAGE, THEY MADE IT UNDERSTOOD THEY MIGHT NOT BE ABLE TO AFFORD TO DO THIS IN THE FUTURE. HE REFERRED TO DEPUTY CLERK GLASGOW HAVING SAID TO READ THEIR BUDGET NOTES SHE HAD PROVIDED; AT THE LAST MEETING, THEY WERE IN THE HOLE AND NOW IT APPEARS EVERYTHING IS TAKEN CARE OF.

DEPUTY CLERK GLASGOW AGREED AND REFERRED TO THEIR BUDGET NOTES ON THE TRANSFER OF FUNDS FROM COMPREHENSIVE PLANNING GRANTS THAT HAVE BEEN CLOSED OUT TO THE GENERAL FUND, THE DECREASE OF THE

UNALLOCATED INSURANCE, THE INTEGRATION OF THE GASB DEPARTMENT WITH ANOTHER DEPARTMENT, THE SHERIFF DEPARTMENT DECREASED HIS BUDGET AND THE COUNTY COMMISSIONER BUDGET HAD TO BE INCREASED TO COVER THE COST OF THE SHERIFF'S EMPLOYEES INSURANCE AND THE FIRE DEPARTMENT AND EMS IS FUNDED AT HALF MILL USING ROLL BACK RATE OF 9.0913 WHICH SAVED \$58,286. IF THE BOARD AGREES TO ALL THE BUDGET NOTE CHANGES, THEN THEY WILL HAVE THIS CONTINGENCY OF \$211,604; IF THEY DON'T DO EVERY-THING THAT IS IN THEIR BUDGET NOTES, THE CONTINGENCY WILL BE WIPED OUT. SHE ADDRESSED AFTER REVIEWING THE BUDGET, SHE NOTICED A CLERICAL SALARY FOR DEIDRA PETTIS WAS STILL IN THE BUILDING DEPARTMENT BUDGET AND SHE HAD BEEN TRANSFERRED TO PARK AND RECREATION. THIS WAS

DEDUCTED FROM THE BUDGET. IT IS NOT THIS MONEY JUST CAME OUT FROM UNDER THE WOODWORK; THERE ARE A LOT OF THINGS IN THE BUDGET NOTES AND SHE IS SURE SOME OF THEM ARE NOT GOING TO PASS.

COMMISSIONER HOWELL SAID HE IS NOT AGREEABLE TO THE 9.0913 MILLS. THEY APPROVED IT FOR DISCUSSION AND TO MOVE FORWARD; HOWEVER, HE DOESN'T THINK IT IS FAIR TO ASK THE PEOPLE TO PAY ANOTHER HALF PERCENT EVERY YEAR. HE ADDRESSED HIM BEING AWARE THINGS COST MORE; BUT, IT IS JUST NOT A GOOD TIME TO CONTINUE TO RAISE TAXES. HE WOULD LIKE FOR THE MILLAGE RATE TO BE SOMEWHERE BETWEEN LAST YEAR'S MILLAGE RATE AND THE 9.0913. HE WOULD ALSO LIKE TO SEE THE BOARD MAKE A DECISION TODAY ON EMORY'S STATUS AS FAR AS HIM DOING THE ADMINISTRA-TIVE DUTIES PLUS ALL THE BUILDING INSPECTIONS, ETC. HE SAID THIS WAS NOT FAIR TO MR. PITTS AND DIDN'T THINK IT GIVES HIM A GOOD WAY AS FAR AS HIS JOB EVERY DAY; HE CAN'T REALLY CONCENTRATE ON ANY ONE THING FOR ANY LENGTH OF TIME. HE HAS EITHER GOT TO RUN OUT AND DO A BUILDING INSPECTION OR GO TO A MEETING SOMEWHERE WITH HIS JOB AS COUNTY ADMINISTRATOR OR GO TO TALLAHASSEE FOR SOME REASON.

COMMISSIONER HOWELL STATED HE THOUGHT MR. PITTS HAD DONE AN EXCELLENT JOB AND RECOMMENDED THE BOARD PUT HIM IN THE ADMINISTRA-TIVE POSITION PERMANENTLY, HIRE A PART TIME BUILDING INSPECTOR WITH EMORY CONTINUING TO SERVE AS THE BUILDING OFFICIAL. THE

PART TIME BUILDING INSPECTOR WOULD PROBABLY COST APPROXIMATELY \$20,000 TO \$25,000 A YEAR.

COMMISSIONER HOWELL ASKED MR. PITTS IF HE HAD A PLAN WHERE THE GASB POSITION WAS GOING TO GO. MR. PITTS SAID HE HAD NOT TALKED TO MALCOLM GAINEY ABOUT IT YET; BUT, THAT IS HIS INTENTIONS TO ASSIGN GASB WITH MALCOLM.

COMMISSIONER HOWELL ADDRESSED THE BOARD HASN'T SPOKEN TO THE RECREATION ISSUE AT ALL AND THOUGHT THERE SHOULD BE SOME FUNDING PUT TOWARD THAT.

COMMISSIONER PATE REFERRED TO HIM HAVING SERVED ON THE BUDGET COMMITTEE FOR TWO YEARS AND THEY DIDN'T HAVE A CONTINGENCY; HE THINKS THEY HAVE BEEN VERY FORTUNATE WHERE THEY HAVEN'T HAD TO GO INTO AN EMERGENCY SITUATION WHERE THEY NEEDED SOME KIND OF CONTINGENCY FUND. HE LOVES SEEING A CONTINGENCY FUND IN THE BUDGET. HE DOESN'T HAVE ANY PROBLEMS WITH SOME ADJUSTING; BUT, HE WOULD ENCOURAGE THE BOARD TO HAVE A CONTINGENCY IN THEIR BUDGET. NORMALLY, THIS CONTINGENCY OUGHT TO BE AROUND \$500,000 TO \$1,000,000 AND THEY HAVEN'T EVEN COME CLOSE TO IT.

COMMISSIONER BROCK ADDRESSED HIM HEARING COMMISSIONER HOWELL AND PATE TALKING ABUT THEM SETTING THE TENTATIVE BUDGET FOR 9.0913 MILS. THEY HAVE A BALANCED BUDGET BEFORE THEM; BUT, THEY ARE GOING TO GO AGAINST WHAT HAS BEEN BALANCED AND A CONTINGENCY. RIGHT NOW AS WE SIT HERE, HE DOESN'T KNOW IF THEY ARE GOING TO APPROVE THIS TENTATIVE BUDGET THAT HAS BEEN BALANCED. IF THE BOARD DOESN'T APPROVE IT, THEY DON'T HAVE A CONTINGENCY.

COMMISSIONER PATE SAID HE DIDN'T SAY ANYTHING ABOUT CHANGING THAT; HE SAID HE LOVED THE CONTINGENCY ITEM.

COMMISSIONER BROCK POINTED OUT THEY HAD TO BALANCE THE BUDGET TO HAVE THIS CONTINGENCY; IF THEY DON'T THEY ARE GOING TO HAVE TO GO BACK AND DO SOME CUTTING. BASICALLY, WHAT HE IS SEEING IS THEY MIGHT HAVE A LOT OF HOMEWORK TO DO. HE THINKS THE MAIN THING THE BOARD HAS TO DECIDE HERE TODAY BEFORE THEY GO ANY FURTHER IS WHAT 4-BCC 08-10-2010

BUDGET ARE THEY GOING WITH. ARE THEY GOING BACK THE SAME AS LAST

YEAR OR ARE THEY GOING TO INCREASE A LITTLE BIT ON THE ROLL BACK. COMMISSIONER PATE STATED THE BOARD CAN'T GO BACK TO LAST YEAR'S MILLAGE RATE BECAUSE IT IS NOT IN THE THREE SCENARIOS; THE LOWEST ONE THE BUDGET COMMITTEE GAVE THEM OUT OF THE THREE SCENARIOS WAS STILL HIGHER THAN LAST YEAR'S MILLAGE RATE.

COMMISSIONER HOWELL OUESTIONED WHAT IT WOULD TAKE TO GET TO THE LOWEST MILLAGE RATE SCENARIO. DEPUTY CLERK GLASGOW SAID IT WOULD TAKE A REDUCTION IN THE BUDGET OF \$161,183 TO GET THE MILLAGE RATE LOWERED TO 8.9.

COMMISSIONER HOWELL ASKED IF THIS WAS TRUE AFTER ALL THE CHANGES ARE MADE PER THE BUDGET NOTES. DEPUTY CLERK GLASGOW SAID THE BOARD HAS A CONTINGENCY RIGHT NOW; BUT, BEFORE THEY CAN DECIDE ANYTHING THEY WILL NEED TO DETERMINE IF THEY ARE GOING TO GO ALONG WITH ALL THESE ITEMS AND HAVE A CONTINGENCY OF \$211,604. THE BOARD CAN CUT THE BUDGET BY THIS AMOUNT; BUT, THEY WON'T BE ABLE TO FUND ALL THEIR WANTS AND WISHES.

THE BOARD ADDRESSED THE BUDGET NOTES ONE AT A TIME:

1. \$104,247 TRANSFERRED FROM COMPREHENSIVE PLANNING GRANTS THAT HAVE BEEN CLOSED OUT. \$49,000 PUT IN COMPREHENSIVE PLANNING GRANT FOR EAR UPDATES; \$45,000 FOR WFRPC AND \$4,000 FOR SOFTWARE, ETC. THIS LEAVES A BALANCE OF \$55,247. THIS WOULD BE NON-REOCCURRING MONIES. THE BOARD'S CONSENSUS WAS TO APPROVE OF ITEM 1.

2. UNALLOCATED INSURANCE REDUCED BY \$35,000. ACTUAL COST THIS YEAR PLUS ADJUSTMENT FOR ANTICIPATED INCREASE WAS \$35,000 LESS THAN AMOUNT BUDGETED FOR 2009-2010. DEPUTY CLERK GLASGOW STATED SHE FELT COMFORTABLE DECREASING THIS INSURANCE BY THE \$35,000 AND POSSIBLY MORE.

COMMISSIONER HOWELL QUESTIONED WHAT THE UNALLOCATED INSURANCE WAS. DEPUTY CLERK GLASGOW SAID IT WAS FOR FACT LIABILITY, AUTO, INLAND MARINE AND PROPERTY INSURANCE.

3. AMOUNT TRANSFERRED TO THE BUILDING DEPARTMENT OUT OF THE

GENERAL FUND WAS DECREASED BY \$33,438 DUE TO POSITION THAT WAS TRANSFERRED TO PARKS AND RECREATION NOT TAKEN OUT OF BUILDING DEPART-MENT'S PROPOSED BUDGET FOR 2010-2011.

4. GASB BEING INTEGRATERD WITH ANOTHER DEPARTMENT SAVED \$35,564. MR. PITTS HAD SUGGESTED DOING THE INTEGRATION WITH ANOTHER DEPARTMENT.

FIRE DEPARTMENT AND EMS FUNDED AT HALF MIL USING ROLL BACK 5. RATE OF 9.0913. THIS WOULD BE A SAVINGS OF \$58,286. DEPUTY CLERK GLASGOW EXPLAINED BOTH THE FIRE DEPARTMENT AND EMS HAS BEEN FUNDED AT THE SAME AMOUNT REGARDLESS OF WHAT THE HALF MIL GENERATED AND THEY CAN BE AGAIN AS THAT IS STRICTLY UP TO THE BOARD. THIS WOULD BE A DECREASE IN FUNDING FOR BOTH THE FIRE DEPARTMENTS AND EMS.

THE BOARD'S ACTION PREVIOUSLY WAS TO FUND EMS AND THE FIRE DEPARTMENTS AT HALF MIL; BUT, THE BOARD HAS CONTINUED TO BUDGET THEM WHAT THE HALF MIL GENERATED WHEN THEY STARTED FUNDING THE HALF MIL AND IT HAS NEVER DECREASED.

COMMISSIONER STRICKLAND VOICED HIS OPINION THE AMBULANCE AND THE FIRE DEPARTMENTS NEED THEIR MONEY; THEY DON'T NEED TO BE CUT.

6. COMMISSIONERS FUNDED AT \$250 A MONTH FOR IN COUNTY TRAVEL WOULD SAVE \$33,000. COMMISSIONER BROCK, HOLMAN AND STRICKLAND SAID THEY WOULDN'T AGREE TO THIS.

COMMISSIONER HOWELL ADDRESSED THE BOARD HAVING ASKED EVERYBODY TO CUT SOMETHING; THE LEAST THEY CAN DO IS CUT SOMETHING. MAYBE BEING CUT TO \$250 IS TOO MUCH; BUT, THEY NEED TO CUT SOMETHING. THEY HAVEN'T CUT ANYTHING ON THEIR SIDE OF THE FENCE EVEN THOUGH THEY HAVE ASKED EVERYBODY ELSE TO DO IT.

COMMISSIONER PATE SAID HE HAS ASKED THE IN COUNTY TRAVEL TO BE CUT EVER SINCE HE HAS BEEN ON THE BOARD AND ALL HE HAS GOT IS COMMENTS ABOUT IS "WE ARE NOT WELL OFF LIKE MR. PATE AND MR. HOWELL." YOU DON'T HAVE TO BE WELL OFF; YOU JUST HAVE TO TREAT PEOPLE RIGHT. IF HE IS OFFENDING SOMEBODY WITH HIS COMMENTS, HE IS NOT BACKING UP. IF THEY DON'T CUT THE TRAVEL MONEY, HE IS GOING TO PROPOSE THEY KEEP A LOG OF THE ACTUAL TRAVEL THEY TRAVEL AND GET REIMBURSED.

COMMISSIONER STRICKLAND SAID THEY DONE THAT ONE YEAR BEFORE AND THEY DIDN'T PASS THE MONEY THEY SHOULD HAVE BEEN GETTING. STRICKLAND TOLD PATE IF HE DIDN'T WANT THE MONEY, HE DIDN'T HAVE TO TAKE IT AND REFERRED TO A PREVIOUS COMMISSIONER GIVING HIS MONEY BACK TO THE COUNTY.

COMMISSIONER PATE SAID HE UNDERSTANDS THAT; BUT, IF YOU EARN THE TRAVEL MONEY YOU SHOULD GET IT. HE HAS A HARD TIME BELIEVING THEY ARE EARNING WHAT THEY ARE RECEIVING. HE DROVE EVERY MILE HE COULD THAT FIRST YEAR HE WAS ON THE BOARD AND THERE WAS NO WAY IT WOULD COME UP TO THAT.

COMMISSIONER STRICKLAND SAID HE DIDN'T MIND DOING A LOG EVERY MONTH. THE COMMISSIONERS KEEP UP WITH THEIR MILEAGE AND THE ONES THAT DON'T RIDE AS MUCH OR GOES AROUND AS MUCH BRINGS EVERYBODY'S DOWN. ALSO, FIVE YEARS AGO HE SAID SOMETHING ABOUT LETTING THE COUNTY GET THE COMMISSIONERS A VEHICLE AND THEY COULDN'T DO THAT.

TODD ABBOTT, IN REFERENCE TO ITEM 6 ON THE COUNTY COMMISSIONER'S TRAVEL MONEY, ASKED HOW MUCH EACH COMMISSIONER RECEIVED FOR IN COUNTY TRAVEL. DEPUTY CLERK GLASGOW ADVISED THEY EACH RECEIVED \$800 A MONTH. MR. ABBOT QUESTIONED IF EVERYBODY ELSE IN THE DIFFERENT DEPART-

MR. ABBOT QUESTIONED IF EVERYBODY ELSE IN THE DIFFERENT DEPART-MENTS HAD BEEN ASKED TO CUT BACK AND ASKED IF IT WOULDN'T RIGHT TO ASK ALL THE COMMISSIONERS TO DO THE SAME. THIS IS TAXPAYERS MONEY. EACH COMMISSIONER SITTING ON THE BOARD RECEIVES A SALARY, IN HIS OPINION, THAT OVERCOMPENSATES FOR THE ELECTED POSITION. HE ASKED ABOUT DOING AWAY WITH COMMISSIONERS MILEAGE CHECK. COMMISSIONER BROCK AND HOLMAN SAID THEY WOULDN'T GOING TO DO AWAY WITH THE MILEAGE CHECK.

COMMISSIONER STRICKLAND STATED THE STATE STATUTE SAYS YOU CAN'T DO AWAY WITH IT. TODD QUESTIONED IF THEY COULD CUT BACK ON THE AMOUNT OF THE MILEAGE CHECK. DEPUTY CLERK GLASGOW SAID SHE DIDN'T KNOW ABOUT A STATE STATUTE THAT SAYS YOU CAN'T DO AWAY WITH IT.

7. THE SHERIFF DEPARTMENT IS FUNDED THE SAME AS THE CURRENT YEAR; BUT, THERE IS AN INCREASE TO THE COUNTY COMMISSION BUDGET FOR

THE SHERIFF DEPARTMENT HEALTH INSURANCE AT \$56,344.

SHERIFF HADDOCK ADDRESSED THE BOARD ON HIM HEARING RUMORS; BUT, HE NEEDS TO KNOW ABOUT THIS INSURANCE. WHAT THE PROBLEM IS, THEY WAIT UNTIL THE LAST MINUTE IN THEIR BUDGET EVERY YEAR AND THEN HE HAS PEOPLE ON STAFF THAT ARE CONCERNED BECAUSE THEY DON'T KNOW IF THEY ARE GOING TO HAVE INSURANCE NEXT YEAR. THIS IS NOT THE TIME THIS LATE IN THE BALLGAME TO DO AWAY WITH PEOPLE'S INSURANCE. THEY CAN'T GO OUT AND BUY OTHER INSURANCE. HE HAS STAFF THAT IS PREGNANT, GOING TO HAVE KIDS AND IF THE BOARD DOES AWAY WITH FAMILY COVERAGE. WHERE ARE THESE PEOPLE GOING TO GET INSURANCE AT. WHO IS GOING TO PICK THEM UP. PEOPLE WITH PRE-EXISTING PROBLEMS, WHERE ARE THEY GOING TO GET THE MONEY OR THE INSURANCE; THEY ARE NOT GOING TO BE INSURED. THIS MONSTER WAS CREATED FOUR YEARS AGO AND IT WAS SAID THEN, IT WAS GOING TO BE A PROBLEM; BUT, NOW THE MONSTER HAS BEEN CREATED. THE BOARD CAN STOP FEEDING IT IF THEY WANT TO; BUT, THEY CAN'T DO THAT AT THE END AT THIS TIME. THIS IS THE TIME EVERYBODY IS TRYING TO GET INSURANCE AND EVERYBODY IS GETTING QUOTES AND OPEN ENROLLMENT. AT ONE TIME, BECAUSE OF THE INSURANCE CHANGING FROM DAY TO DAY, THEY WERE TALKING ABOUT NOT INSURING KIDS INDIVIDUALLY; HE THINKS THAT HAS CHANGED JUST RECENTLY. HE ASKED THE BOARD TO TAKE INTO CONSIDERATION ALL THE STAFF BECAUSE THEY CAN'T GO OUT AND GET INSURANCE RIGHT NOW IF THEY HAVE PRE-EXISTING AND IF THE STAFF IS PREGNANT. THE SHERIFF SAID HE WISHES THEY COULD START SITTING DOWN AFTER THIS BUDGET AND NOT WAIT UNTIL NEXT JULY OR AUGUST TO WORK ON IT; IF THEY HAVE ISSUES WITH THESE THINGS, THEY NEED TO START AS SOON AS THEY CAN AND START DEALING WITH THESE ISSUES, SEE WHAT IS OUT THERE AND GO FOR-WARD BECAUSE NEXT YEAR IS GOING TO BE EVEN WORSE THAN THIS YEAR. HE HAS BEEN PREACHING THAT FOR FOUR YEARS AND THERE IS A TRAIN WRECK COMING DOWN THE ROAD FOR THIS COUNTY IF THEY DON'T START PLANNING AHEAD. THEY CAN'T WAIT UNTIL THE END OF THE YEAR; IT IS GOING TO TAKE ALL THE CONSTITUTIONAL OFFICERS, THE BOARD, THE SUPERVISORS OF DIFFERENT DEPARTMENTS TO COME TOGETHER AND START PLANNING DOWN

THE ROAD. ON THE INSURANCE, HADDOCK TOLD THE BOARD THEY NEEDED TO TAKE INTO CONSIDERATION IF THEY DO AWAY WITH IT WHAT IS GOING TO HAPPEN AND THE CONSEQUENCES TO THEIR STAFF. HE ADDRESSED HIM HAVING A MAJOR STAFF MEETING YESTERDAY; HE HAS PEOPLE THAT ARE GOING TO HAVE TO LEAVE AND GO SOMEWHERE ELSE TO TRY AND GET INSURANCE. IF THE BOARD IS GOING TO DO AWAY WITH THE INSURANCE, NOW IS NOT THE BEST TIME TO DO AWAY WITH IT.

COMMISSIONER HOWELL ASKED SHERIFF HADDOCK IF HE THOUGHT IT WAS RIGHT TO ASK THE TAXPAYERS OF THIS COUNTY TO CONTINUE FUNDING DEPENDENT HEALTH CARE.

SHERIFF HADDOCK SAID OTHER COUNTIES FUND IT; IF THEY GO TO Page 5

BAY COUNTY SHERIFF'S OFFICE, IT IS 71%, 75% AND 73%. HE JUST WENT AND LOOKED AT THEIR NUMBERS. IF YOU GO TO THE STATE, WHAT DO THEY PAY. THE COUNTY HAS CREATED THIS AND THEY CAN'T WAIT UNTIL THE LAST MINUTE TO DO SOMETHING WITH THE INSURANCE.

COMMISSIONER HOWELL TOLD SHERIFF HADDOCK THE INSURANCE COMPANIES WON'T GIVE THEM A RATE UNTIL THE END OF THE YEAR; YOU CAN'T GO OUT NEXT WEEK AND GET RATES FOR NEXT YEAR.

SHERIFF HADDOCK SAID THEY USUALLY GET RATES EARLIER THAN THIS. BUT, THIS YEAR BECAUSE OF THE PLAN FROM THE FEDERAL GOVERNMENT, IT IS ALWAYS TO PUT IT OFF. SHERIFF HADDOCK REFERRED TO SHERIFF MCKEITHAN HAVING TO CUT \$3,000,000 FROM HIS BUDGET. IF WE START CUTTING TO THE BONE; HE KEEPS HEARING HIRE THIS, HIRE THAT, HIRE THIS BUT OVER HERE, WE HAVE TO BALANCE IT OFF THE BACK OF OUR EMPLOYEES. WHAT IS FAIR; WHAT IS RIGHT.

COMMISSIONER HOWELL REFERRED TO SHERIFF HADDOCK HAVING SAID SHERIFF MCKEITHAN HAD TO REDUCE HIS BUDGET BY \$3,000,000 AND TOLD HADDOCK HIS DIDN'T GET REDUCED: THE BOARD INCREASED HIS.

HADDOCK HIS DIDN'T GET REDUCED; THE BOARD INCREASED HIS. SHERIFF HADDOCK SAID "YES, IT DID GET REDUCED BECAUSE HE ABSORBED \$68,000 IN HIS BUDGET HE HAS TO FIND."

COMMISSIONER HOWELL SAID IT IS BASICALLY A WASH BECAUSE THE SHERIFF ABSORBED \$68,000; BUT, THE BOARD HAD TO FUND A \$56,344 INCREASE FOR THE SHERIFF'S EMPLOYEE INSURANCE. SHERIFF HADDOCK SAID HE WAS GOING TO HAVE TO CUT SOMETHING FROM HIS BUDGET TO OFFSET THE \$68,000.

SHERIFF HADDOCK SAID IT WAS \$59,000 FOR HIS RETIREMENT INCREASE AND THERE WAS \$60,000 FOR INSURANCE; HE ABSORBED THE \$59,000 IN THE BUDGET. SOMETHING SOMEWHERE IS GOING TO BE CUT IN THAT BUDGET.

COMMISSIONER HOWELL TOLD SHERIFF HADDOCK HE WAS GETTING THE SAME BUDGET HE HAD LAST YEAR. SHERIFF HADDOCK SAID THEY COULD SAY THAT; THE OLD SAYING IS YOU CAN FIGURE IT EITHER WAY YOU WANT TO FIGURE IT.

SHERIFF HADDOCK SAID THREE OF THE FIVE COMMISSIONERS HAS GOT TO DECIDE THAT; BUT, HE HAS SAID THIS FOR FIVE YEARS, THERE IS A TRAIN WRECK COMING. IF THE BOARD THINKS IT IS BAD NOW, IF HE LOSES THAT FL-DOC CONTRACT AND THEY LOSE SOME OTHER MONEY, THAT IS A HALF MILLION DOLLARS AND QUESTIONED WHERE IS THAT GOING TO COME FROM. HE BEGGED THE BOARD AT THE TIME NOT TO PUT THE FL-DOC MONIES IN THE BUDGET; BUT, IF IT IS GONE, THEY ARE GOING TO HAVE TO SEND PEOPLE HOME. THEY HANDED THE FULL INCREASE DOWN TO THE EMPLOYEES. RATHER THAN CUTTING OUT THE FAMILY PLANS, ETC. AND MAYBE WHERE THEY CAN PLAN TO LOOK AT THIS IN ADVANCE IN THE FUTURE, COULD THE COUNTY COMMISSION TAKE THEIR FULL INCREASE OF INSURANCE PREMIUMS AND PASS IT ON TO THE EMPLOYEES. COMMISSIONER HOWELL SAID THEY COULD CHANGE THEIR ENTIRE PLAN AND FUND HOW MUCH OF IT THEY WANT TO.

SHERIFF HADDOCK SAID THE UNDERSTANDING HE HAS IN TALKING WITH HIS AGENT WITH BCBS, THAT WAS ONE OF THE THINGS THEY FOREWARNED THEM ABOUT AND ONE OF THE THINGS THEY TRIED TO SIT DOWN AND DO, WAS TO DO AN INCREASE FOR THE EMPLOYEES TO PAY MORE. HIS UNDERSTANDING THROUGH THE AGENT, THEY CAN ONLY INCREASE THE EMPLOYEES PAYMENT BY 5%; THAT IS THAT NEW FEDERAL STUFF.

THE BOARD TENDS TO KEEP ABSORBING THIS COST EVERY YEAR AND RAISING THE TAXES EVERY YEAR AND IT IS NOT RIGHT TO DO THAT TO THE TAXPAYERS OF THIS COUNTY. MR. PITTS ASKED IF THE BOARD WAS GOING TO GIVE HIM DIRECTION ON BEING ABLE TO HIRE A BUILDING INSPECTOR.

COMMISSIONER HOWELL SAID HE HAD MENTIONED THIS PREVIOUSLY THAT HE FELT LIKE THEY OUGHT TO MOVE EMORY INTO THE ADMINISTRATIVE POSITION AND MOVE FORWARD WITH HIRING A PART TIME BUILDING INSPECTOR. COMMISSIONER HOWELL THEN OFFERED A MOTION TO MOVE EMORY INTO THE ADMINISTRATIVE POSITION AND HIRE A PART TIME BUILDING INSPECTOR.

COMMISSIONER BROCK STATED THEY WERE ALREADY IN THE RED IN THE BUILDING DEPARTMENT SOME \$80,000 A YEAR. COMMISSIONER PATE SECONDED THE MOTION.

WES FISHER SAID LETS TALK ABOUT PRIORITY AND THE WORDK "IF." PRIORITY RIGHT NOW AND THEY HAVE FOUGHT ALL DAY ABOUT INSURANCE. THE BOARD IS TALKING ABOUT HIRING THIS, MOVING THAT. RIGHT NOW THEY HAVE ALL THIS BUDGET PROBLEM. THEY ARE TALKING ABOUT PUSHING A HIGHER MILLAGE RATE TO EVERYBODY IN THE COUNTY, CUTTING INSURANCE TO 25-BCC 08-10-2010

EMPLOYEES WHILE TALKING ABOUT TAKING SOMEBODY THAT IS A BUILDING INSPECTOR AND MAKING HIM AN ADMINISTRATOR AND HIRING ANOTHER INDIVIDUAL TO BE A BUILDING INSPECTOR. HE ASKED FOR WHAT AND FELT THEY COULD COUNT ON ONE HAND HOW MANY BUILDINGS ARE BEING BUILT RIGHT NOW. THIS COUNTY IS POOR AND THE BOARD IS PROVING IT WITH EVERY WORD THEY SPEAK, EVERYTHING THEY ARE ARGUING ABOUT; NOT ENOUGH, NOT ENOUGH. LET'S HIRE A SUPERVISOR TO SUPERVISE TWO MORE; THEY HAVE BEEN TALKING ABOUT THAT. LET'S HIRE ANOTHER BUILDING INSPECTOR PART TIME, LET'S HIRE TDC A FULL TIME EMPLOYEE; LET'S HIRE THIS, LET'S THROW MORE MONEY AT THE PROBLEM. IF THE BOARD KEEPS HIRING, KEEPS HIRING AND KEEPS HIRING, NEXT YEAR LET'S SEE HOW HIGH THEIR MILLAGE RATE WILL BE THEN. THE BOARD IS GOING THE WRONG WAY.

COMMISSIONER HOWELL SAID THERE IS NO INCREASE IN WHAT THEY ARE TALKING ABOUT; NONE WHATSOEVER.

MR. FISCHER SAID WATCH AND SEE.

MR. PITTS, TO ADDRESS WHAT STATEMENTS MR. BROCK MADE ABOUT THE BUILDING DEPARTMENT BEING IN THE RED BY \$80,000, THAT FIGURE IN THE SALARY DEPUTY CLERK GLASGOW TOLD THEM ABOUT EARLIER HAS BEEN CHANGED AND HE ACTUALLY HAS A COPY OF THAT. IN THE PROPOSED BUDGET FOR THE BUILDING DEPARTMENT FOR NEXT YEAR, THE GENERAL FUND IS CONTRIBUTING \$53,000 TO THE BUILDING DEPARTMENT. IN THAT \$53,000, \$30,000 OF THAT IS CODE ENFORCEMENT THAT USE TO GO TO PLANNING. THEY HAD NO PROBLEM GIVING IT TO PLANNING TO FUND A POSITION; BUT, IT WAS JUST TRANSFERRED TO THE BUILDING DEPARTMENT WHEN THE JOB WAS TRANSFERRED TO THE BUILDING DEPARTMENT. HE DOESN'T FEEL LIKE THAT IS A TRUE FIGURE WHEN YOU SAY THE BUILDING DEPARTMENT HAS JUST BEEN GIVEN \$30,000 OUT OF THE GENERAL FUND. THEY WERE ALSO GIVEN A JOB TO DO FOR THAT \$30,000. THAT ACTUALLY LEAVES \$23,000 THE BUILDING DEPARTMENT IS IN THE RED IF THEY WANT TO CALL IT THAT. IF HIS SALARY WAS TRANS-FERRED TO ADMINISTRATION, THAT IS A SAVINGS IN THE BUILDING DEPARTMENT OF \$70,000, SO THAT MAKES IT \$50,000 TO THE GOOD NOW. THEY ARE TALK-

ING ABOUT HIRING A PART TIME BUILDING INSPECTOR FOR \$20,000 SO THEY ARE NOW \$30,000 TO THE GOOD IN THE BUILDING DEPARTMENT. THAT IS WHAT THEY ARE TRYING TO DO IS FIX A PROBLEM; IT IS NOT GOING TO CREATE ONE.

COMMISSIONER BROCK SAID MR. PITTS WAS SAYING A \$20,000 POSITION AND ASKED WHY THE COUNTY HASN'T CONTRACTED AND USED THAT \$20,000 POSITION IN THE COUNTY FOR THE BUILDING DEPARTMENT. YOU CAN CONTRACT.

MR. PITTS TOLD MR. BROCK THEY COULDN'T CONTRACT A BUILDING OFFICIAL FOR \$20,000 A YEAR; WHEN LLOYD POWELL WAS DOING THIS JOB, HE WAS MAKING OVER A \$100,000 A YEAR BEING CONTRACTED WHEN THINGS WERE GOOD AND THEY WOULD TAKE 80% OF THE BUILDING DEPARTMENT'S INCOME AND THE COUNTY WILL STILL MAINTAIN AN OFFICE. CONTRACTING IT OUT WILL NOT FIX THE PROBLEM IN THE BUILDING DEPARTMENT. AS FAR ES AS WHAT MR. FISHER WAS SAYING ABOUT COUNTING THE NUMBER OF BUILDING PERMITS ON YOUR HAND, THAT IS NOT EXACTLY TRUE. SOME DAYS HE CATCHES

TEN BUILDING INSPECTIONS WHEN HE GETS THROUGH WITH THE ADMINISTRATION JOB. SOME DAYS HE ONLY HAS TWO OR THREE. SOME DAYS HE IS OUT UNTIL 6:30 P.M. TO 7:00 P.M. BEFORE HE FINISHES HIS INSPECTIONS AND HE HAS BEEN DOING THAT NOW FOR SIX MONTHS.

MR. PITTS ADDRESSED THE BUILDING DEPARTMENT IS A VERY IMPORTANT DEPARTMENT AND IT HAS COME A LONG WAY IN THE LAST FOUR YEARS; THEY HAVE FIXED A LOT OF ILLS IN THAT DEPARTMENT AND HE WOULD CERTAINLY HATE TO SEE IT GO BACK TO WHAT IT WAS FOUR YEARS AGO BY CONTRACTING IT OUT TO SOMEONE. THE CONTRACTED POSITION WOULDN'T TAKE THE INTEREST IN THE DEPARTMENT THAT AN EMPLOYEE IS GOING TO TAKE AND AREN'T GOING TO BE RESPONSIBLE FOR IT; THEY ARE GOING TO BE INTERESTED IN COLLECTING THE FEES AND PUTTING THE FEES IN THEIR POCKET WHETHER THE INSPECTIONS GET DONE OR NOT. HE ADDRESSED THE COUNTY HAS AN OBLIGATION TO THE PEOPLE; IT IS LIFE SAFETY JUST LIKE EMS OR THE FIRE DEPARTMENT. IF HOUSES DON'T HAVE SMOKE DETECTORS IN THEM TO GET PEOPLE OUT, IT IS NOT GOING TO DO A WHOLE LOT OF GOOD WHEN THE FIRE DEPARTMENT GETS THERE.

COMMISSIONER BROCK ASKED WHO SECONDED THE MOTION. CHAIRMAN HOLMAN SAID COMMISSIONER PATE HAD SECONDED THE MOTION.

COMMISSIONER PATE ASKED WHAT IT MATTERS WHO SECONDED THE MOTION. COMMISSIONER BROCK TOLD COMMISSIONER PATE HE WASN'T GETTING INTO AN ARGUMENT WITH HIM.

COMMISSIONER HOWELL SAID THEY HAD ALREADY VOTED AND ASKED COM-MISSIONER BROCK TO VOTE YES OR NO. COMMISSIONER BROCK SAID HE WAS GOING TO SAY HIS PEACE; HE WAS ENTITLED TO THAT. THE ADMINISTRATIVE POSITION CALLS FOR A VERY HIGHLY QUALIFIED PERSON AND IT SHOULD CARRY A DEGREE FOR THE PROFESSION AND HE THINKS RIGHT NOW THIS COUNTY IS GO-ING ON THE WRONG TRACK. IT IS GOING DOWN JUST LIKE MR. FISHER SAID BY THEM MOVING EMPLOYEES AROUND. HE DON'T HAVE NOTHING WITH EMORY; EMORY TOLD HIM PLAINLY, HE MIGHT DENY THIS, HE DIDN'T KNOW NOTHING ABOUT AN ADMINISTRATION JOB. IT WAS ALL NEW TO HIM. COMMISSIONER BROCK SAID THIS IS POLITICAL MESS HE FEELS THE COUNTY IS DOING RIGHT NOW AND HE WOULD LIKE TO SEE THE COUNTY ADVERTISE FOR A QUALIFIED PERSON. THEY SHOULD HAVE WENT THE ROUTE OF DOING APPLICATIONS, INTERVIEWING AND SCREENING FOR THIS POSITION. THIS IS THE HIGHLY MOST IMPORTANT POSITION IN THIS COUNTY. HE JUST FEELS LIKE THEY ARE DOING WRONG.

CLERK COOK SAID EMORY HAS TAKEN IT ON HIMSELF TO LEARN AND DO AND HE DOES A WONDERFUL JOB; NOT JUST FOR HER BUT FOR THE BOARD AS A WHOLE. SHE SAID SHE DON'T CARE HOW EDUCATED EMORY IS, HE HAS DONE A WONDERFUL JOB.

CHAIRMAN HOLMAN ASKED BROCK TO VOTE EITHER YES OR NO ON THE

SHERIFF HADDOCK ADDRESSED THE BOARD AND SAID MR. PITTS MIGHT HAVE SAID HE WAS NOT QUALIFIED; BUT, HE HAS DONE A DEARN GOOD JOB. EDU-CATION IS NOT EVERYTHING; IT COUNTS IN A LOT OF PLACES BUT MY GRACIOUS IN TIMES WE HAVE NOW AND THE PROBLEMS WE HAVE WITH THE BUDGET WE ARE HAVING NOW AND THE TAXES, ETC. COMMISSIONER BROCK SAID FROM NOW ON LETS DON'T HAVE COLLEGE EDUCATION DEGREES, ETC. IN APPLICATIONS FOR THE COUNTY.

SHERIFF HADDOCK SAID HE DIDN'T HAVE A COLLEGE EDUCATION; BUT, HE HAS THIRTY TWO YEARS OF HARD KNOCKED EXPERIENCE THAT TELLS HIM WHAT TO DO.

COMMISSIONER BROCK ADDRESSED A LOT OF THE COUNTY POSITIONS CALL FOR A DEGREE. MR. PITTS SAID THIS POSITION DOES NOT; IT IS RECOMMENDED BUT IS NOT REQUIRED.

MR. PITTS SAID HE HAD NO ISSUE; HE WOULD GO BACK TO THE BUILDING DEPARTMENT AND BE GLAD TO.

CHAIRMAN HOLMAN SAID THE MOTION CARRIED 4-1 WITH COMMISSIONER BROCK OPPOSING.

CHAIRMAN HOLMAN ADJOURNED THE MEETING.
