VICE-CHAIRMAN ABBOTT ADDRESSED THE AUDIENCE THAT THIS IS A JOINT EFFORT BETWEEN THE FLORIDA STATE UNIVERSITY AND THE UNIVERSITY OF FLORIDA. THEY ARE PROVIDING THIS TO FOUR COUNTIES AT AN EXPENSE OF \$495,000.00 TO THE UNIVERSITIES OVER AN 18 MONTH PERIOD AT NO COST.

ATTORNEY GOODMAN ADDRESSED THE BOARD THAT IT WAS BROUGHT TO HIS ATTENTION EARLIER THAT THERE MIGHT NOT BE A QUORUM AT TODAY'S MEETING. HE CONTACTED THE OVERSIGHT PARTIES WITH IFAS WHO ALLOWED HIM TO DRAFT A LETTER OF SUPPORT FROM THE CHAIRMAN WHICH HE DID, OR A DESIGNEE OF THE COUNTY AND MAKE THE LETTER CONTINGENT UPON THE BOARD TAKING ACTION ON IT BY THE END OF MAY IN A REGULAR MEETING.
