II. ADOPT THE AGENDA

**Commissioner Joyner offered a motion, seconded by Commissioner Kent and unanimously carried to adopt the agenda.**

IV. AGENDA ITEMS

- Rescind Burn Ban – Attorney Milton read the resolution 2020 – 18 by title.

**Commissioner Abbott offered a motion, seconded by Commissioner Bush and unanimously carried to rescind the recent burn ban via resolution 2020 – 18.**

Commissioner Abbott questioned if County Administrator Massey could implement and rescind a burn ban.

County Attorney Milton advised the board that he would rather they make that decision.

- Ag Center Roof Change Order – Chairman Hawkins advised that the change order is for \$27,588.00.

**Commissioner Abbott offered a motion, seconded by Commissioner Joyner to approve the change order for the ag center for discussion.**

County Administrator Massey advised that when the façade was removed, unforeseen damage was discovered.

**The motion carried unanimously.**

- Cope Road Change Order – Karen Shaw, Grants advised that the change order is needed due to existing areas of asphalt failure/base

repair. The change order is \$22,035.00.

**Commissioner Kent offered a motion, seconded by Commissioner Abbott and unanimously carried to approve the change order for Cope Road for \$22,035.00 contingent upon state approval.**

- Old Bonifay Change Order – Karen Shaw advised the board that the change order for Old Bonifay is due to asphalt failure, as well. The change order is \$7,825.00.

**Commissioner Abbott offered a motion, seconded by Commissioner Kent and unanimously carried to approve the change order for Old Bonifay Road for \$7,825.00 contingent upon state approval.**
