### III. AGENDA ITEMS

• Extension of the 2020 Tax Roll – Tray Hawkins, Chairman informed the board if the petition that is coming before the VAB is not settled an extension of the tax roll will be required.

Commissioner Joyner offered a motion, seconded by Commissioner Abbott, and carried to approve of the 2020 tax roll extension.

Ag Center Electrical Needs – Kevan Parker addressed the board regarding the ag center livestock building repair. It has been determined by the contractor that the conduit for every receptacle at the ag center livestock building is rusted away below ground level. Every receptacle had a 20-amp breaker. Every pod had 80-amps of electricity.

Kevan Parker requested approval for himself, County

Administrator Massey, and Chairman Hawkins to review/negotiate
the bids when they are received today.

Kevan Parker advised that he intends to meet with Mark Mauldin to confirm what is needed.

Commissioner Abbott offered a motion, seconded by
Commissioner Bush for discussion. The motion carried to
approve of Kevan Parker, County Administrator Massey, and
Chairman Hawkins to enter into negotiations with the
contractor on the price of the electrical work for the ag center

### livestock building.

Commissioners Bush and Kent advised that the wiring should be done at the same standards it was at.

 Headwalls – Kevan Parker addressed the board regarding headwalls that don't have existing culverts. At the notice to proceed with A & W Excavation, a price was requested from them for the installation of Sakrete bags in places that didn't have headwalls. A & W quoted \$19.50 per bag.

The cost of the headwall is around \$1,400.00.

County Administrator Massey confirmed with Kevan Parker that these are headwalls that don't have anything at all and are causing continuous maintenance problems. This would alleviate problems when rain is abundant. The quote provided does include labor and material.

Chairman Hawkins confirmed that Johnny Evans and Kevan Parker would work together selecting the areas.

Paving is the top priority for the county.

County Administrator Massey questioned if this would be captured under the storm money.

Kevan Parker advised that is correct; Michal and Sally.

	Johnny Evans informed the board that an estimated 40 bags per side would be needed.		
	The board held a discussion and decided to table the Sakrete bags for the headwalls.
