2. PUBLIC HEARING

1. Fiscal Year 25/26 Final Millage Rate and Final Budget Chairman Pettis Statement – The Washington County Board of County Commissioners' millage rate to be levied remains at 8.50, which is 7.80 percent above the rolled-back rate of 7.8847. The reason ad valorem tax revenues are increasing is that the gross taxable value for operating purposes for this fiscal year is \$1,489,953,620.00 compared to \$1,343,651,067.00 for the previous fiscal year.

This meeting was advertised via the Washington County News on September 17, 2025.

Benita Crittendon questioned where the \$2.9M listed on page 2 came from and if it is being used to balance the 2025 - 2026 budget.

Chairman Pettis responded that the funds were ARPA Funds that were used throughout the 2024 - 2025 budget to replenish general fund expenses.

Benita Crittendon responded that the cash carried forward account still had a balance of \$2.9M as of Septembers report. Are the funds planned to be used in the next two weeks? It looks like the funds are being used in the proposed budget with a projected balance of \$354,000.00 at the end of the next budget year.

Chairman Pettis responded that \$354,000.00 was transferred from land sales to balance the 2025 – 2026 budget.

Deputy Clerk Brantley said that line item shows what the budget was at the beginning of the year. Finance does not typically charge an expense to a revenue. It would be charged at an expense. It is a revenue total. You may see it increasing.

Benita Crittendon said that it shows 0% used. It is ARPA money. The ARPA money does not show any movement from the cash carried forward account. ARPA money is not supposed to be in a cash carried forward account. It should be kept separate until it is used.

Clerk Bell responded that it was no longer ARPA money when it replenished the general fund for government salaries, which was approved by the board via resolution.

Benita Crittendon suggested that a forensic audit of Washington County be considered. If a commissioner feels like they have not received a full answer to something questioned, then the vote should reflect that for individual protection.
